
The Graphical representation of responses for statement 1-19 are depicted in graph 1-19 for parents:

Table No. 01 shows that 59 parents agree with the statement and 9 parents disagree.




The figure No. 01 shows that 86.76% parents agree with the above mentioned statement, and 13% of parents disagree with the above mentioned statement.




The Figure No. 02 shows that 91.98% parents agree with the above mentioned statement, and 8.82% of parents disagree with the above mentioned statement.


The Figure No. 03 shows that 90% parents agree with the above mentioned statement, and 10% of parents disagree with the above mentioned statement.




The Figure No. 04 shows that 97% parents agree with the above mentioned statement, and 21% of parents disagree with the above mentioned statement.


The Figure No. 05 shows that 85% parents agree with the above mentioned statement, and 15% of parents disagree with the above mentioned statement.




The Figure No. 06 shows that 74% parents agree with the above mentioned statement, and 26% of parents disagree with the above mentioned statement.
